

# Extraordinary release of National Accounts on 16 May 2024

On 30 May 2024 the time series for the Gross Domestic Product (GDP) and other key measures in the National Accounts will be revised following a benchmark revision. The main features as well as preliminary results for the reference year 2021 were published in March, for more information please visit [National Accounts, quarterly and annual estimates \(scb.se\)](#)

However, prior to the ordinary release, revised series covering *Labour input* will be disseminated in the Statistical Database. Within the benchmark revision, labour input has been revised due to changes in methods and sources. On 16 May the results of these revisions will be published for the quarters and years 1993-2023Q4. The decision to release these series ahead of time was prompted by user requests for earlier data access.

Another feature of the 2024 benchmark revision is the implementation of the new COICOP (2018) manual for the classification of household consumption expenditure by purpose. This implies that the publication on 30 May will be according to the new COICOP structure. To facilitate for our users, tables according to the new structure, but void of actual
