

# Item description for reporting by file:

## Wage and salary structure statistics, private sector (AM/SLP)

**1 September – 30 September 2025**

The item descriptions are intended for:

- Those who are responsible for reporting data for Statistics Sweden's salary structure statistics (AM/SLP).
- Those who are responsible for processing payroll data for the company's employees.

Statistics Sweden can accept files in two different formats – an Excel template and a data file in which the item description is the same for Statistics Sweden and the Confederation of Swedish Enterprise.

The Excel template can be obtained from [www.scb.se/slp-en](http://www.scb.se/slp-en).

Statistics Sweden and the Confederation of Swedish Enterprise use a common item description for reporting salary data at the individual level. Each item consists of a fixed part where the variables are in fixed positions (positions 1–70) and a variable part (positions 71–300) which consists of a control code and value for each variable. If a data item is missing, enter zeros.

The variables in the surveys of Statistics Sweden and the Confederation of Swedish Enterprise differ somewhat however, and different control codes are thus used for certain variables depending on whether it is Statistics Sweden or the Confederation of Swedish Enterprise requesting the statistics. The part with fixed positions also contains variables that are to be submitted to Statistics Sweden or the Confederation of Swedish Enterprise only.

### Reporting

The statistics are reported by logging in at [www.scb.se/slp-en](http://www.scb.se/slp-en) using your username and password provided in the information letter. First, some questions are answered about the company in an online form, followed by instructions on how to proceed for sending the file. If your payroll system is not devised in a way that it can produce a report containing the requested data, there is a prepared excel template that can be obtained from [www.scb.se/slp-en](http://www.scb.se/slp-en).

There is space for 23 fields: control code and value. The control code consists of three digits, as shown below. The value is a seven-digit value and is entered justified to the right and filled out with zeros. Codes 003 and 004 are stated with two decimal places without a separator. E.g. agreed weekly working hours is 38.50 – for code 003 the value is 0003850. For code 051, the amount is stated in whole Swedish kronor for monthly and weekly paid employees, a monthly salary of 23 756 SEK is entered as 0023756 (no decimals). For hourly paid employees, the amount is stated with decimals; hourly wage of 75.50 is entered as 0007550.
