Statistics Sweden describes Sweden

Statistics Sweden provides society with statistics for decision-making, debate and research on behalf of the Government, government agencies, researchers and the business sector. These statistics contribute to factbased public debate and informed decisions.

Statistics Sweden is responsible for parts of the official statistics of Sweden, including statistics on education of the population. This survey aims to improve the statistics on the education of immigrants. For this reason, your answers are just as important whether you attended school or not. There is a maximum of five questions to be answered.

Your answers are important

Taking part in the survey is voluntary, but your participation is very important. The survey shows the skills and knowledge that immigrants bring to Sweden.

The survey has been sent to everyone aged between 20 and 59 years who immigrated to Sweden in the past year and for whom information about the highest level of educational attainment is missing from Statistics Sweden's Register of Education. This corresponds to about 60 000 people.

Who will use the answers and how?

Once Statistics Sweden has collected the answers, we compile them into statistics in the form of tables and graphs that show the educational background of the population by factors such as sex, county, municipality, age and country of birth.

Statistics Sweden may also release information to researchers or other producers of statistics. Release of data is restrictive and follows special review. These types of research and statistical activities are also subject to statistical confidentiality (see below).

How are my answers protected?

When the results are presented it will not be possible to see any individual answers.

Information about an individual's personal and financial circumstances is kept confidential and everyone working on the survey is bound by the duty of professional secrecy. Confidentiality applies in accordance with Chapter 24, Section 8 of the Public Access to Information and Secrecy Act (2009:400).

How is personal data processed?

Statistics Sweden is the controller of the personal data that is processed by Statistics Sweden. Provisions on processing personal data are contained in the EU General Data Protection Regulation (GDPR), the Official Statistics Act (2001:99), and the Official Statistics Ordinance (2001:100). In addition, there are rules in the Act on Supplementary Provisions to the EU General Data Protection Regulation (2018:218) and in regulations issued in association with this Act.

You have the right to obtain a copy, free of charge, in the form of a register extract, of the personal data processed by Statistics Sweden in its capacity of personal data controller. More information is available at www.scb.se/registerutdrag.

Should you find that Statistics Sweden has processed your personal data in a way that contravenes the EU General Data Protection Regulation, you have the right to have your personal data deleted, under certain circumstances.
